Goyder Wind Farm Common Asset Pty Ltd ACN 649 966 138

## Exemption

- 1. Pursuant to section 80(1) of the *Electricity Act 1996* (**Act**), and subject to the conditions specified below, the Essential Services Commission (**Commission**) grants Goyder Wind Farm Common Asset Pty Ltd (ACN 649 966 138) an exemption from the application of part 3 of the Act in relation to the transmission of electricity from Burra to Robertstown, South Australia.
- 2. The exemption continues until revoked by the Commission or by operation of law.
- 3. The grant of the exemption is subject to the following conditions:
  - a. Goyder Wind Farm Common Asset Pty Ltd must inform the Commission, in writing, of any changes made or proposed to be made to its electricity operations, which would result in it providing electricity to additional customers, materially changing current arrangements, or ceasing transmission operations.
  - b. Goyder Wind Farm Common Asset Pty Ltd must comply with all applicable laws.
  - c. Goyder Wind Farm Common Asset Pty Ltd must provide the Commission any information reasonably sought by the Commission from time to time.
  - d. Goyder Wind Farm Common Asset Pty Ltd must comply with any safety, reliability, maintenance and technical management plan requirements imposed by the Technical Regulator under section 60B of the Act.
  - e. Goyder Wind Farm Common Asset Pty Ltd must maintain adequate and appropriate insurance, given the nature of those operations carried out under the exemption and the risks entailed in those operations, including insurance against any liability for causing bush fires.
  - f. Goyder Wind Farm Common Asset Pty Ltd must, following a request from the Australian Energy Market Operator (**AEMO**), provide to AEMO, such documents or information as it may reasonably require to perform its functions and exercise its powers under the Act.
  - g. Goyder Wind Farm Common Asset Pty Ltd must comply with any directions given to it by the system controller.
  - h. Goyder Wind Farm Common Asset Pty Ltd must not do anything to its network affecting the compatibility of its Network with any electricity generating plant, or a distribution network or a transmission network, so as to prejudice public safety or the security of the power system of which the Network forms a part.
  - i. Goyder Wind Farm Common Asset Pty Ltd must plan and design its transmission networks and ensure that it is operated to comply with:
    - I. the performance standards applicable to the generating plant connected to the transmission network
    - II. the connection agreement between itself and the transmission network operated by ElectraNet Pty Ltd, and
    - III. applicable system standards under the National Electricity Rules.
